The [SA8000® Standard](#) is a leading social certification standard for factories, farms and organizations across the globe. The SA8000 Standard includes both performance requirements and strong management system implementation to enable systemic, sustainable and continual improvement. SAI's programs have helped transform global workplaces and supply chains through standards and assurance systems; corporate advisory services; technical assistance for licensees, vendors, factories and farms; training and capacity-building for workers, managers, social auditors and consultants.

## MEMBERSHIP

SAI membership is not a prerequisite for supplier participation in the SA8000 audit program. Walmart is not currently a member of SAI.

## SA8000 SUPPORT

The [SA8000 certification process](#) consists of an online self-assessment, an evaluation by an [accredited certification body](#), and ongoing on-site monitoring. SA8000 certification lasts for three years, with a series of required surveillance audits throughout the three year period. Organizations may recertify at the end of the third year.

## SHARE FACILITY REPORTS WITH WALMART

Provide visibility to facility information and audit reports to Walmart with the steps below. SAI does not currently offer a platform to share audit reports.

### Step 1: Obtain the audit report and certification

The facility owns the SA8000 certification documentation and can provide copies on request. Share these documents with Walmart per the requirements below.

### Step 2: Document requirements

#### A. For **Pre-Certified** Facilities (Stage I complete):

- *Audit Report* with auditor's comment – "Proceed to Stage II"

#### B. For **Initially-Certified** Facilities (Stage II complete):

- *Initial Certification Audit Report*
- *Corrective Action Report/Non-Conformities Report/Findings Report* - to provide details of any identified non-conformities
- *Corrective Action Report (CAR) approved by the Certification Body (CB)* - to demonstrate closure of any identified non-conformities
- *Certificate*

#### C. For **Currently-Certified** Facilities (Stage II complete):

- *Most Recent Certification/Recertification Audit Report*
- *Most Recent Surveillance Audit Report* - if one has been conducted
- *Corrective Action Report/Non-Conformities Report/Findings Report* - to provide details of any identified non-conformities
- *Corrective Action Report (CAR) approved by the Certification Body (CB)* - to demonstrate closure of any identified non-conformities (from either audit)
- *Certificate*

*\*To be accepted by Walmart, the audit must be conducted by an APSCA-registered or certified auditor on behalf of an APSCA member firm. View APSCA member audit firms [here](#). Confirm with your selected program that the approved firm and auditor are in good standing with APSCA.*
