

Region/Territory Category List

The Walmart Responsible Sourcing and Supply Chain Security programs use a risk-based approach to auditing that focuses audit resources on geographic areas that have higher potential for risk and non-compliance. Using supply chain data provided by the British Standards Institute (BSI), Walmart places each region/territory into one of three risk categories. While the data from BSI is a key element of the risk-based approach to auditing, Walmart reserves the right to incorporate other data or risk factors into its risk-based approach and the assignment of regions/territories to a Category.

Prequalification Requirements

In addition to these region/territory-based auditing requirements, suppliers associated with new or reactivated Direct Import facilities (facilities where Walmart is the importer of record) will be required to obtain a prequalification audit for such facilities prior to producing product for Walmart. Once this requirement is satisfied, auditing requirements for the facility are those set forth above based on region/territory category.

- Category 1 and Category 2 facilities must receive an Orange, Yellow, or Green rating in order to meet pregualification requirements.
- Category 3 (high risk region/territory) facilities must receive a Yellow or Green rating in order to meet prequalification requirements.

Walmart may, from time to time, ask suppliers with facilities producing certain kinds of products, or in certain industries, to obtain additional audits. Walmart reserves the right to examine other factors and to evolve its audit approach and requirements over time.

Other areas within Walmart may require factory audits. These may include Food Safety audits, Factory Capability and Capacity audits, or others. Legal prohibitions or other Walmart restrictions on sourcing from certain regions/territories may apply.

Risk-Based Approach to Auditing

Each region/territory is placed into one of three risk categories. Audit requirements for disclosed facilities under each category are as follows:

• Category 1 Regions/Territories – Lower Risk: New requirement for Responsible Sourcing as of April 2024: all direct import and domestic factories making private brand or generic brand will be subject



to relevant RS audit requirements and will be moved into a routine audit cadence—regardless of sourcing geography. This will be a phased implementation through FY28. Audit follow-up will be dictated by the supplier's chosen third-party audit program.

Supply Chain Security (SCS) requires all new DI facilities where Walmart is the importer of record to obtain an audit outlined in the Prequalification Requirements above. Once that requirement is satisfied, the SCS program does not require suppliers to submit an audit for facilities in Category 1 regions/territories on a regular schedule. Rather, Walmart will select a sample of such facilities annually and suppliers associated with selected facilities will be required to submit an audit to Walmart. Any facility in a Category 1 region/territory may be selected as part of this sample.

- Category 2 Regions/Territories Medium Risk: Suppliers are required to complete a third-party audit for facilities in Category 2 regions/territories and continue with follow-up audits so that facilities maintain a valid audit at all times. Audit reports are valid for a period of time determined by each program. In cases where a program does not specify, Walmart will set an expiration date.
- Category 3 Regions/Territories Higher Risk: Suppliers are required to complete a third-party audit for all facilities in Category 3 regions/territories and the audit must receive a Green or Yellow assessment before the facility can produce for Walmart. Suppliers must continue with follow-up audits so that facilities in Category 3 regions/territories maintain a valid audit at all times. Audit reports are valid for a period of time determined by each program. In cases where a program does not specify, Walmart will set an expiration date. Walmart may choose to deny authorization of a facility disclosed in a Category 3 region/territory where no other facilities are currently disclosed and authorized for production. Walmart will review on a case-by-case basis and may deny activation of the facility based on risk, even if the region/territory is not subject to legal prohibitions or other Walmart restrictions. Contact RS Compliance to determine whether Walmart is allowing sourcing from the Category 3 region/territory.

Prohibited Regions/Territories

Legal and other restrictions prohibit suppliers from sourcing¹ product, or products' components/ingredients/raw materials, for Walmart from the following regions/territories:

- Cuba
- Iran
- North Korea
- Syria

- Belarus
- Burma
- Turkmenistan
- Uzbekistan

¹ Sourcing product, or products' components/ingredients includes those that are grown, produced, manufactured, extracted, processed in, sourced from, or transported through any of the Prohibited Regions/Territories.



- Crimean Peninsula, Donetsk People's Republic (DNR) and Luhansk People's Republic (LNR) Regions
- Xinjiang Uyghur Autonomous Region

• Russia

Doing so may lead to supplier consequences, up to and including termination of the supplier's business relationship with Walmart and/or a facility's ability to produce goods for sale at Walmart.
