WRAP is the world's largest independent factory-based social compliance certification program for the sewn products sector, including apparel, footwear, mills, leather goods, luggage and accessories. WRAP is dedicated to promoting safe, lawful, humane and ethical manufacturing around the world through certification and education. WRAP focuses on 12 principles that cover a wide range of ethical manufacturing areas including security. WRAP audits are accepted by Walmart to satisfy both Supply Chain Security and Responsible Sourcing (RS) requirements.

SHARE FACILITY REPORTS WITH WALMART

Provide visibility to facility information and audit reports to Walmart with the steps below.

Step 1: Request to list Walmart as buyer in the WRAP certification platform.

If a facility starts online application with WRAP, view instructions here to add Walmart as a buyer. If the facility has finished the online application or is certified, send an email request to hmei@wrapcompliance.org to list Walmart as a Buyer in the WRAP certification platform.

Step 2: Download the Audit Report and Certificate

Confirm the supplier and Walmart are listed as buyers for the facility. The audit report and certificate can be downloaded and shared with Walmart.
