#### **ACCIDENT OR ILLNESS?**

#### FILE A LEAVE OF ABSENCE CLAIM

If you're not able to work due to illness, injury, or pregnancy, disability coverage can provide financial support while you're away. Eligibility and state variations apply.

#### PILOTS

For purposes of benefits provided under the short-term disability plan, "disabled" or "disability" means that

- You are unable to perform the essential duties of your job for your normal work schedule,
   or a license required for your job duties has been suspended due to a mental or physical illness or injury, or pregnancy, and
- You are under the continuous care of a qualified doctor and are following the course of treatment prescribed by your doctor.

Disability benefits are payable during a loss of license only while you are disabled and pursuing reinstatement of your license on a timely basis.

- Timely pursuit of reinstatement means you apply for reinstatement when your condition
  meets the criteria, and you provide information and forms requested by the licensing
  agency on a timely basis until your license is reinstated.
  - o Loss of license by itself is not sufficient for meeting the definition of disability.
  - o Pilots must report all Provider and FAA appointments to Sedgwick to ensure all leave of absence dates are accurate.

Disability benefits are payable during a loss of license only while you are disabled and pursuing reinstatement of your license on a timely basis.

- Timely pursuit of reinstatement means you apply for reinstatement when your condition meets the criteria, and you provide information and forms requested by the licensing agency on a timely basis until your license is reinstated.
- Loss of license by itself is not sufficient for meeting the definition of disability.
- The determination of whether you are disabled is made by Sedgwick based on objective medical evidence, which consists of facts and findings, including but not limited to X-rays, laboratory reports, tests, consulting physician reports as well as reports and chart notes from your physician.

#### PAYING FOR YOUR BENEFITS

Your share of the cost for your benefits is normally taken out of your paycheck automatically. If you're away on leave, things work a bit differently.

- If you're on an approved short-term disability claim, your benefits payments will be automatically deducted from your disability check or direct deposit in most states.
- If you don't have an approved short-term disability claim, you'll need to cover your benefits payments yourself.
