

Mental health at Walmart


You've got support for all aspects of life. You can choose how to protect and enhance your mental health: in-person or virtually, with self-directed tools, or with a caring professional.

Access a group chat monitored by a trained moderator and connect anonymously with people who are dealing with similar struggles as you.

Take a guided microbreak to reduce stress, reset, and refocus by downloading an app directly to your Walmart Microsoft Teams account.

Get help when you need it most.

Everyone needs help from time to time. A licensed clinician may reach out to you to check in, offer support, or connect you with other benefits.

Take time away.

Focus on the things that matter most with paid time off, or qualifying paid or unpaid leaves of absence.
