FY26 Q3 Talking points for leaders



This quarter, we're focusing on how Walmart benefits can help protect mental, physical, and financial well-being, so associates can be prepared to make informed decisions for their health and wealth. Use these talking points to discuss the featured programs with your associates.

## What we're talking about in Q3

This quarter's Live Better Bulletin explores these benefits:

- Finding the right fit for your mental health:
   Understand the multiple ways you and your family members can access mental health care. Learn about the options through Lyra and Doctor On Demand by Included Health.
  - **Eligibility:** All Walmart associates can access some mental health programs, like therapy and mental health coaching through Lyra; others require Walmart medical plan enrollment, like mental health support through Doctor On Demand by Included Health.
- 2. Healthy habits made easy: Choose from programs that feel right for where you are today and help you maintain wellness. Eat better, move more, and manage stress with support from resources like Fresh Tri, myAgileLife, Fitness Pass, and Breakthru.

- 6. Naming beneficiaries: Keeping your beneficiaries' information updated helps make sure your benefits, like 401(k) and life insurance, are paid according to your wishes.
